

# Privacy Policy

## Overview

FINEXGROW is committed to safeguarding the confidentiality and protection of its clients' personal and financial data. By registering for a trading account, clients acknowledge and authorize the collection, use, processing, and storage of their personal data as outlined below.

## Collection of Personal Information

To open and manage a trading account, facilitate transactions, and ensure the security of client funds and information, FINEXGROW collects personal data necessary for providing its services. Information may be gathered directly from clients or, in certain cases, from banks, credit institutions, clearing houses, or other relevant entities to build a client profile that aligns with their preferences and trading needs.

This data may include, but is not limited to, contact details, identity verification information, demographic data (such as date of birth, educational background, and profession), and trading behaviour.

## Use of Personal Information

Client data is used solely for service delivery, maintaining security, enhancing client experience, and informing clients of relevant products, services, and promotional offers. By agreeing to this policy, clients give consent for their data to be used in this way. ## Data Protection Measures

All personal data provided by clients is handled as confidential and is only shared internally within FINEXGROW and its affiliates. Such data will not be disclosed to external parties unless legally required or mandated by a

regulatory authority. In these instances, disclosure is limited to only what is strictly necessary and the third party is informed of the confidential nature of the information.

### **Information Sharing with Affiliates and Partners**

FINEXGROW may share client information with affiliated entities when necessary to deliver requested products or services. Additionally, with the client's prior consent, FINEXGROW may disclose information to affiliates, partners, or associated firms offering complementary services that match the client's needs.

### **Third-Party Disclosures**

The Company does not rent, sell, or otherwise distribute personal information to unrelated third parties, except where:

- Required by law or regulation
- Requested by government or regulatory authorities
- Necessary for credit checks or collections
- Needed for outsourced services such as data processing, account handling, surveys, or customer support

These third parties are strictly limited in their use of the data and are required to protect it under applicable laws, following standards equivalent to FINEXGROW's.

Where clients are introduced via a Business Introducer, such introducers may access client data. By agreeing to this policy, clients consent to such sharing.

### **Regulatory Disclosure**

FINEXGROW reserves the right to disclose client information if legally obligated by courts, regulators, or law enforcement agencies. Any disclosure

will be limited to what is necessary and, unless otherwise directed, the receiving party will be notified of the confidential nature of the information.

---

### **Client Communication**

The Company may contact clients periodically via email or phone with updates, service information, or promotional opportunities. By accepting the Company's terms of use, clients consent to such communication. Clients who prefer not to be contacted can request removal from contact lists by emailing or calling FINEXGROW.

---

### **Third-Party Website Links**

FINEXGROW is not responsible for the privacy practices or content of any external sites linked on its website. When clients visit third-party or co-branded websites, any data shared will be subject to that third party's privacy policy.

---

### **Use of Cookies**

Cookies are employed to secure user sessions and improve website functionality. These cookies do not store sensitive personal data. FINEXGROW may share anonymous usage data with reputable advertising and analytics providers. These third parties may use cookies on the Company's behalf to collect statistical data about website traffic and performance.

### **Privacy Policy Revisions**

FINEXGROW may revise this Privacy Policy at any time. If material changes are made regarding how client data is handled, the updated policy will be posted on the Company's website. By continuing to use the services after such updates, clients agree to the revised terms. Clients are encouraged to
